



“G3 ADVANTAGE” FACTORY LIMITED WARRANTY

Highlights-Please review and read this entire limited warranty for complete terms and conditions.

- **Five (5) YEAR BOW TO STERN BOAT LIMITED WARRANTY**
- **LIMITED LIFETIME EXTERNAL SEAMS AND DECK WARRANTY TO ORIGINAL OWNER**
- **BOW TO STERN LIMITED WARRANTY TRANSFERABLE TO SECOND OWNER WITHIN 5 YEARS OF ORIGINAL PURCHASE.**
- **1 YEAR COMMERCIAL LIMITED WARRANTY FROM DATE OF RETAIL SALE.**

This limited warranty provides you with protection against the expense of repairs for your boat that are required as a result of defects in materials or workmanship. This limited warranty provides you with specific coverage and notes your responsibilities in maintaining and operating your boat. Please take the time to read and become familiar with this limited warranty.

PERIOD OF LIMITED WARRANTY: Any new **G3 Boat or SunCatcher Pontoon** purchased for personal, family or household use from any authorized G3 Boat or SunCatcher Pontoon dealer in 50 U.S. States, U.S. territories and U.S. jurisdictions, and Canada, will be warranted against major structural defects in material or workmanship as follows: (i) Limited Lifetime External Seams and Deck: main riveted and welded seams in hull to include keel, outside chine and transom to hull seam riveted and welds for the duration of ownership of the first retail purchaser from an authorized G3 dealer; (ii) Five (5) Year Bow to Stern Limited Warranty: structural components, including other welds, bulkheads, stringers, and rivets and select non-structural components, as follows: gauges, stereo, vinyl, and furniture (except as noted otherwise under General Exclusions) are warranted against defects in material or workmanship for a period of five (5) years from the date of purchase subject to the limitations as outlined below.

MARINE GRADE PLYWOOD AND OEM COMPONENTS: Plywood and OEM components may be subject to a separate warranty provided by the manufacturer, other than G3.

CONDITIONS OF WARRANTY: The product must be registered for warranty coverage by an authorized G3 Boats dealer within fifteen (15) days from the original retail purchase date. Dealer shall identify the product by product serial number, customer name, address and contact information. No warranty claim will be considered, approved or paid unless the warranty is completed and registered with G3 as proof of purchase.

FIVE YEAR BOW TO STERN LIMITED WARRANTY TRANSFER: The first retail purchaser of a new G3 boat from an authorized G3 Dealer may transfer the warranty to a second retail purchaser, during the first five (5) years after the original purchase of the first retail purchaser. The transfer of warranty will not extend the five (5) year period set forth in this limited warranty. The transferee will only be covered for the remainder of the original five (5) year period. Coverage remaining may be transferred by providing G3 with written notice of the

transfer within thirty (30) days after the date of such transfer. The warranty may only be transferred once. Such notice will be effective when received by G3 at 901 Cowan Drive, Lebanon, MO 65536.

LIMITED LIFETIME EXTERNAL SEAMS AND DECK WARRANTY TRANSFER: The first retail purchaser of a new G3 Boat from an authorized G3 Dealer may transfer the warranty to a second retail purchaser, during the first five (5) years after the original purchase of the first retail purchaser. Upon a transfer as provided herein, the limited warranty will be for a term of five (5) years from the date of the original purchase from the authorized G3 dealer and will no longer be a lifetime limited warranty. Coverage remaining may be transferred by providing G3 with written notice of the transfer within thirty (30) days after the date of such transfer. The warranty may only be transferred once. Such notice will be effective when received by G3 at 901 Cowan Drive, Lebanon, MO 65536.

OBTAINING REPAIRS UNDER WARRANTY: During the period of warranty, G3 or its authorized dealer will free of charge, repair or replace, at its sole discretion, any part adjudged defective by G3 due to faulty workmanship or material from the factory provided the original owner returns the boat, with transportation prepaid to an authorized G3 dealer or, if necessary, to the G3 factory or any other reasonable place designated by G3. Should G3 elect to replace the entire boat, the replacement boat shall be subject to an extended or new warranty, in G3's sole discretion, unless otherwise agreed to by G3 in writing.

The boat owner will be responsible for all transportation, haul outs, loss of time, inconvenience, travel expense, loss of use, towing, storage, and other expenses incurred in returning the boat for warranty service. All parts replaced under warranty shall become the property of G3.

CUSTOMER'S RESPONSIBILITY: Under the terms of this warranty, the customer will be responsible for ensuring the boat is properly operated, maintained and stored as specified in the applicable owner's manual. The owner shall return the boat to an authorized G3 dealer for review of all reported warranty defects within this specified warranty period, or if directed by G3, to the G3 factory. Warranty repairs will be performed by G3 or its authorized representative in accordance with the other provisions of this limited warranty.

GENERAL EXCLUSIONS: This warranty will not cover the repair of damages to your boat caused by abuse, alteration, modification, neglect, vandalism, failure to adhere to product capacity information plate and/or product maintenance and care instructions. Examples of damage caused by abuse, alteration, modifications, neglect, vandalism and non-adherence include, but are not limited to the following:

1. Window breakage, and leakage around windows, or hatches or other apertures.
2. Deterioration caused by exposure to the elements or the use of cleaners or chemicals or anti-fouling paint not recommended in writing by G3.
3. Installation of engines or accessories installed by anyone other than G3 or an authorized G3 dealer.
4. Abuse, alteration, modification, neglect or vandalism to upholstery, canvas, zippers, vinyl, plastics, fabric, trim wood (with the exception of rot); or rips, tears, and fading to carpets and upholstery.
5. Damage, including normal deterioration, caused by overpowering or overloading according to the maximum horsepower specifications on the capacity plate provided on each G3 boat.
6. Damage caused by Acts of God.
7. Dealer preparation including but not limited to cleaning and final adjustments or alignments in preparing the boat for final delivery.
8. Damage caused by improper use of the trailer.
9. Damage resulting from the boat being involved in an accident.
10. Damage caused by improper winter storage, including livewell systems not properly winterized in freezing climates.
11. Damage resulting from non-compliance with G3's maintenance and care instructions or other specifications.
12. Damage caused by ordinary wear and tear.

- 13. Galvanic or stray current corrosion, or corrosion caused by salt or brackish water.
- 14. Damage to the colorfastness of materials caused by overexposure to the sun or improper covering and storage.
- 15. Damage or deterioration caused by exposure to the elements or the use of cleaners or chemicals or anti-fouling paint not recommended in writing by G3.
- 16. This warranty does not cover any failure of boat to meet any representation as to the boat's performance characteristics, including but not limited to estimated speed, weight of the boat, or fuel consumption.
- 17. This warranty does not cover any failure or defect caused by non-authorized G3 dealer repair, unless G3 pre-approved the work in writing.
- 18. This warranty does not cover any G3 boat with an engine setback that is not recommended, approved or optioned for use on the boat.
- 19. Damage caused by engines, canvas, powertrains, outdrives, propellers, controls, batteries, engine brackets, trailers, electric trolling motors, fish/depth finding devices, other equipment or accessories not manufactured by G3 whether or not warranted by other such manufacturer.
- 20. This warranty does not cover any items on the boat that are not manufactured by G3, except as otherwise provided in this limited warranty.

G3 COMMERCIAL LIMITED WARRANTY: G3 warrants to the first retail owner of any new G3 Boat or SunCatcher Pontoon, purchased from an authorized G3 dealer, engaged in commercial trade or that carries passengers for hire (defined as "Commercial") that G3 will repair or replace, at its sole option, any major structural defects in material or workmanship of the main riveted and welded seams in hull to include keel, outside chine and transom to hull seam riveted and welds for one (1) year from the date of the first retail sale from an authorized G3 dealer. **THIS COMMERCIAL LIMITED WARRANTY IS NOT TRANSFERRABLE.**

G3 MAKES NO OTHER WARRANTY OF ANY KIND, EXPRESS OR IMPLIED. ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE EXCEED THE OBLIGATION AND THE LIMITS STATED IN THE WARRANTY ARE HEREBY DISCLAIMED BY G3 AND EXCLUDED FROM THIS WARRANTY.

SOME STATES DO NOT ALLOW LIMITATION ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

THIS WARRANTY DOES NOT COVER ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING LOSS OF USE, LOSS OF TIME, AND INCONVENIENCE, AND G3'S LIABILITY IS LIMITED TO REPAIRING OR REPLACING THE BOAT AS PROVIDED IN THIS WARRANTY. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU.

THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS. AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE. THIS WARRANTY SHALL APPLY IN ACCORDANCE TO THE LAWS OF THE STATE OF MISSOURI.

THIS DOCUMENT CONTAINS THE ENTIRE WARRANTY GIVEN BY G3 AND THERE ARE NO TERMS, PROMISES, CONDITIONS OR WARRANTIES OTHER THAN THOSE CONTAINED HEREIN. NO ORAL OR WRITTEN INFORMATION OR ADVANCE GIVEN BY G3, ITS DEALERS, REPRESENTATIVES, AGENTS OR EMPLOYEES SHALL CREATE A WARRANTY BY G3 OR IN ANY WAY INCREASE THE SCOPE OF THIS WARRANTY.
